

South Skyline Association 2025 Grant Program

The South Skyline Association is now inviting proposals to be funded under its 2025 Grant Program. Application deadline: March 31, 2025

What is the goal of the SSA Grant Program?

The goal of the SSA Grant Program is to provide funding for capital improvements, including repairs and tangible equipment, to support and strengthen organizations and projects in the South Skyline area.

Who is eligible to apply?

Individuals, students, teachers, groups, and organizations are eligible for grant funding.

What proposals will be considered?

The SSA Grant Program will fund proposals for capital improvements, including repairs and tangible equipment.

Three general criteria will be applied:

- 1) grants will support projects that align with the mission of the South Skyline Association (**above**).
- 2) grants will support applicants who sign a statement of non-discrimination in relation to their activities and their proposal.
- 3) grants will not support proposals that include direct political action.

How much money will be granted to successful applicants?

In general, the SSA Grant Program will consider projects at levels up to **\$10,000**.

What is the grant proposal application deadline?

Applications must be submitted by **March 31, 2025**.

Incomplete or late applications will not be considered.

What features is the SSA Grant Program looking for in projects?

The SSA Grant Program will give highest priority to capital improvements for projects that:

- Directly address environmental, educational, or social issues that affect the health and welfare of South Skyline residents.
- Demonstrate the greatest impact, benefit and yield to the mission of the SSA Grant Program.
- Provide the greatest benefit to residents of the South Skyline area.
- Demonstrate the potential for achieving the highest value with respect to the public interest and/or best utilization of grant funds.
- Demonstrate future and/or long-term benefits.

What types of projects does the SSA Grant Program discourage?

The SSA Grant Program will not award grants for the following:

- Operating expenses, training programs, salaries
- Endowments, building campaigns, annual fund appeals or fundraising events.
- Religious organizations for religious purposes.
- Existing obligations, debt retirement, deficits or retroactive funding.
- Political or lobbying activities.
- Hiring grant proposal writers.

How do I apply?

Complete the questions directly onto the PDF version of this application and email to grants@southskyline.org. This is a fillable form and answers can be typed into the text boxes. Save the edited form before attaching it to the email. It must be postmarked by **on September 31, 2024.**

When will awards be made?

The SSA Board of Directors review all applications at the next board meeting.

If my project is funded, what do I need to do when my project is completed?

All successful grant applicants will be required to submit documentation that the grant funds have been spent on the capital improvement(s) included in the proposal. This must be done in the form of a final report which includes: copies of receipts for all items and services purchased with grants funds, photos showing items purchased and/or improvements made, and a brief description of the project. The final report is due within three months of the receipt of the grant. If project is not completed within 3 months of receiving the grant, a project update report must be submitted.

How are applications reviewed and awards decided?

The South Skyline Grant Program is administered by a committee established by the Board of Directors of SSA. The SSA Grant Program Committee will screen all applications to ensure that they meet the above requirements. It will then read and evaluate all screened applications in terms of the selection criteria and recommend funding awards to the SSA Board of Directors. The Board of Directors, at their sole discretion, decides which grant proposals to fund and the amounts to be funded for each proposal. All decisions of the Board of Directors are final. Members of the Committee will notify all applicants in writing of the Board's decision. Following grant awards, funds are normally available for disbursement within twenty-one (21) calendar days.
