

SSA has agreements with Amerigas, Ferrellgas, Kamps, and Suburban Propane Scotts Valley. Existing "Associate Members" will continue to enjoy SPUG discounts, and long-time SPUG members who switch to Ferrellgas will also be eligible for the SPUG discount. Please note: Prices are subject to change as frequently as wholesale prices change. The prices SSA posts are for the first of the month. Our SPUG rate is based on a keep-full basis, not will-call service.

You are not required to pay sales tax on propane if you do not have natural gas available where you use propane. If you get your propane from Amerigas, you will need to submit a sales tax exemption form. Contact Amerigas for the form.

Membership dues are due every January. Those whose SSA membership has lapsed can be disqualified by our propane providers from receiving the benefit of the SPUG price. ## Community Water Tank Grant Program

The SSA is considering the adoption of a sub-grant program that would supply a 5000 gallon water tank to communities for the purpose of having an accessible source of water dedicated for fire mitigation purposes. We have completed a pilot installation.

The grants would possibly cover the cost of the tank itself, a valve with appropriate fire fittings, and delivery. Notionally, the recipients would be responsible for installing the tank and filling it with water. Additional decisions would have to be made regarding specific beneficial location, amenable to access by fire trucks, neighborhood wants, and property easements. Easiest spots would be central to the community, near/on a road, and generally flat to make any grading or site preparation simpler. Installation might involve additional costs depending on the situation. We will provide more information should the SSA formally decide to adopt such a program.

### Fuel Reduction Reimbursement Funds Available

The South Skyline FireSafe Council (SSFSC) has a small fund intended to assist homeowners and road associations with costs for vegetation reduction around homes and/or for clearing along private escape routes and driveways.

This program was created in 2014 to encourage residents within our boundaries to undertake clearing projects. Work can be partially reimbursed by the program through filling out a brief application before beginning work.

A SSFSC board member will inspect the project prior to work beginning and an amount will be determined by the SSFSC Board at the monthly meeting based on specified guidelines and budgetary limits. As an example, the guidelines stipulate a maximum amount of \$350 for contract chipping services for an individual homeowner. Please note, this program is meant to augment, not replace, use of the twice-yearly free chipping program!

### Is Your Home Ready?

You should know that all home owners in the Wildland Urban Interface (WUI), where we live in the Santa Cruz Mountains, are required to maintain a defensible space around all of their structures. This is required by state law, and is one of your best defenses to protect your home from approaching wildfire.

But you may not be aware that an equally important factor whether your home is able to survive a wildland fire or not is "Home Hardening." There are a lot of small things, as well as some large ones, that can be done to assure that your home is less susceptible to blowing embers and approaching flames.

The South Skyline FireSafe Council wants to remind you that we offer a <u>no charge</u> Home Advisory service to help you understand what could be done in and around your home to make it less vulnerable to wildfire. We have six

trained volunteers who can look at your property and the outside of your home and make suggestions to harden the home and improve your

defensible space. The visit usually takes about an hour.

These advisories are only available for properties within the boundaries of the South Skyline FireSafe Council, that is north of Bear Creek Road, South of Old La Honda Road, west to Waterman Gap and Portola State Park Road, East to Redwood Gulch and Alpine Roads.

### South Skyline Community Preparedness Day 2023

On May 21, the South Skyline Emergency Preparedness Organization (SSEPO) and the South Skyline FireSafe Council co-sponsored the second annual South Skyline Community Preparedness Day, 2023. It was a beautiful Spring day at Skyline Ridge Open Space Preserve.

More than 30 agencies and organizations participated this year, including four different fire departments (South Skyline Volunteer Fire & Rescue, engine 29; CalFire; Santa Clara County Fire; and La Honda Fire Brigade) that showed off a variety of their different types of fire engines. San Mateo County Sheriff sent three vehicles including their CAL OES Emergency Communications Truck and their Cliff Rescue Truck. SSEPO showed off their emergency medical trailer and triage tent. San Mateo Large Animal Evacuation Group showed off one of their trailers and were joined by the Santa Cruz Equine Evacuation Group. Midpeninsula Regional Open Space District showed a ranger pick-up truck outfitted with firefighting hoses and pumps and were joined by a ranger from Palo Alto Parks. In addition, we had many other exhibitors including the American Red Cross, California Department of Insurance, South Coast ARES, Community Emergency Response Team, South Bay Fire Wise Partners, United Policy Holders, State Farm Insurance Company, The San Mateo Resource Conservation District, The South Skyline Association and others.

This year, for the first time, we also had private companies who could provide help with making your properties safer: Brush Hog Tree Care, Irish Excavation and Dempsey Engineering (all three providing mastication and brush removal), California Sisters (native plant landscaping), Hardie Company (fireproof walls) and Simply Solar. Also exhibiting was author of a children's book on wildfire, Marjorie Kline and members from the Ramaytush Ohlone Tribe, upon whose ancestral land we held this event

Almost 100 local residents attended. Most of the exhibitors stated that the level of interest and excellent questions asked made this a valuable event. It was also an excellent networking event allowing the various agencies and fire departments to meet each other as well as interact with the visitors and residents. Plan to join us when we do this again next year!














### "The South Skyline Story"

### Rein Orchids Keep in Check

When hiking in our woods June through July, keep a sharp eye out for blooms of rein orchids (*Piperia*). These herbaceous perennials over winter in the soil as round tubers. The above ground portion emerges in spring as 2-4 inconspicuous basal leaves. The leaves are lance-shaped and have parallel veins. As the season progresses, a thin stem emergers, 1 to 2' tall.

Then in late spring to summer, the leaves dry up and wither away. Up to 100 tiny greenish white flowers bloom in a spike along the stem. The flowers have bilateral symmetry with 3 petals and 3 petal-like sepals. The upper sepal is pointed upward at the top. The 2 lower sepals point off the side. 2 lateral petals are between the upper and lower sepals. The lower petal (lip) at the bottom has a spur—a tubular extension growing out from the base.

There are at least two species of rein orchid along Skyline. For Alaska rein orchid (*Piperia unalascencis*), the spur grows back or down and is about as long as the lip, about 1/5". For flat-spurred Piperia (*Piperia transversa*), the lip is about the same size. However, the spur is very long, 2 to 3 times as long as the lip, and perpendicular to the axis of the inflorescence. Flowers can rotate downward as they develop, but the spur will show which petal is the lip. Seeds form in upright capsules along the stem.

When some people hear rein orchid, they think of water drops falling from the sky. Instead, the name recalls a part of horse tack. It may refer to the flower's long spur or to a strap-shaped lip on some species in this genus. I like my reins long.

The scent of Alaska rein orchid has been alternately described as musky, soapy, or honey-like. The scent is to attract pyralid moths and plume moths that pollinate the flowers. Flat-spurred Piperia smells of cloves and is pollinated by geometrid moths. Using their proboscis, the moths pick up packets of pollen from pollen-laden structures called pollinaria and transfer the pollen to another flower.

The Latin genus name of rein orchids has changed back and forth over time. Currently <u>The Jepson Manual</u> lists this as *Piperia*. In the past, the genus name was *Habenaria*, which refers to the Latin for rein. The species name transversa means turned across, while *unalascencis* refers to Unalaska, an island in the Aleutian chain.

Flat-spurred Piperia is found in the far west from British Columbia to Baja California below 7800'. Alaska rein orchid is found throughout the western U.S. and Canada below 9000'. Locally it occurs in mixed evergreen and redwood forests.
